

How to create a new patient account

On the RocheDiabetes Care Platform



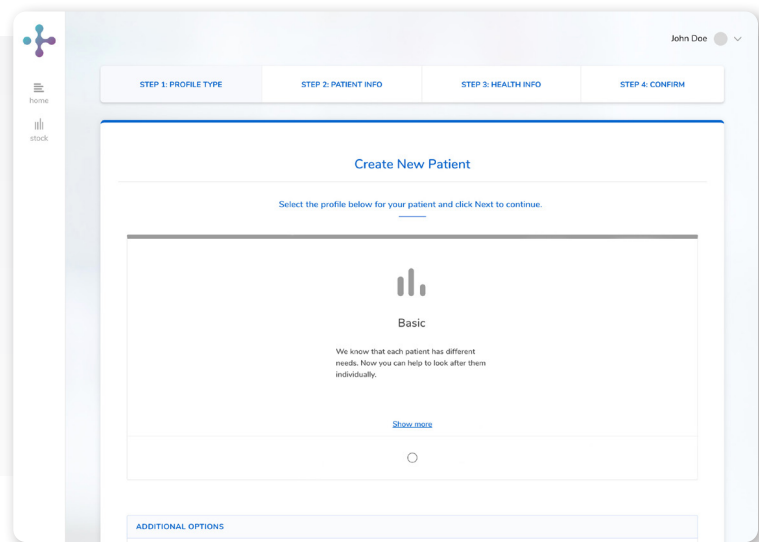

To begin, click on **Create New Patient**.

SELECT PROFILE TYPE

Select a **Profile Type** for your patient.

- **Basic:** Diabetes management only
- As future RocheDiabetes Care Platform Modules become available, you may have more options to select.

ADDITIONAL OPTIONS

- Patient Portal Access**
Allow patient access to the Patient Portal to remotely upload device data. Access permission requires a valid email address from the patient.
- Open Connectivity**
Allow patient to upload data from all product supported devices.
- mySugr Data Sharing**
Allow patient to share data using the mySugr mobile app.

- **Patient Portal Access:** Your patient will receive an email from RDCP to complete their account creation process. You will need a valid email for your patient. If you leave this un-ticked, you can add patient portal access later.
- **Open Connectivity:** Enables patients to upload data from non-Accu-Chek devices.

Using the tick boxes, select the optional data-sharing features you desire for your patient in the **Additional Options** section.

- **mySugr Data Sharing:** Your patient will receive an email from RDCP to complete the account set up process. You will need a valid email from your patient to set up mySugr Data Sharing. If you leave this un-ticked, you can add mySugr data sharing later.

Click **Next** to continue to the next step.

ENTER PATIENT INFORMATION

Here you will fill out the boxes with your patient's details. A patient **Name**, **Surname**, and **Email** address are all required if you selected patient portal access and/or mySugr Data Sharing in Step 1.

A Healthcare ID is Required. You are encouraged to use the EMR number that is associated with this patient in your EMR system.

Click **Next** to continue to the next step.

ENTER HEALTH INFORMATION

Fill out the patient's Health Information on this page.

The **Diabetes Type**, **Associated Professional**, **Gender**, and **Pregnancy (if Female)** fields are all required, but additional information like **Date of Diagnosis** can be helpful.

The **Associated Professional** field defaults to the Healthcare Provider creating the patient profile, but a different clinician can be selected using the drop-down menu.

To add other HCPs in your office, click on **"Your Name"** in the upper right corner of the home screen. Then click **"Add a Professional"** and follow the instructions.

Click **Next** to finish adding the patient.



The system will confirm that the patient has been added, and the patient profile setup is complete.
